AMENDMENT 1

Brings politics into local school boards by changing their elections from non-partisan to partisan.

AMENDMENT 2

Establishes a constitutional right to fish and hunt, already state law, and makes it the "preferred means" of managing fish and wildlife.

AMENDMENT 3

Legalizes the recreational use of marijuana for adults 21 and over.

AMENDMENT 4

Limits the ability of politicians to interfere in the private health care decision to have an abortion.

AMENDMENT 5

Increases the homestead tax exemption annually based on inflation. Cuts funding communities utilize for programs and services.

AMENDMENT 6

Ends Florida's public campaign financing program that provides an incentive for candidates to seek support from everyday citizens, not just wealthy donors and powerful special interests.

AMENDMENT 1

Brings politics into local school board elections by making them partisan. Nullifies part of a 1998 amendment passed by 64% of Florida voters that ensures school board races are nonpartisan. Creates closed party primaries that take away the ability for millions of Floridians to vote in school board elections.

AMENDMENT 2

Establishes a state constitutional right to hunt and fish, even though that right already exists in state law. Proclaims hunting and fishing the 'preferred means of responsibly managing and controlling fish and wildlife,' potentially overriding existing wildlife protections.

VOTE NO: Florida Bar Animal Law Section, Sierra Club Florida, National Council of Jewish Women, Humane Society of the United States, Florida NOW, Florida For All

AMENDMENT 3

Legalizes recreational use of marijuana for adults 21 or older, providing access to safe, regulated marijuana products. Removes criminal penalties for adults 21 and up for simple possession of marijuana in small quantities.

AMENDMENT 4

Ensures that Floridians, not politicians, are able to decide what is best for their own lives and bodies by limiting government interference with abortion. Overturns Florida's abortion ban, which outlaws abortion before many women even realize they are pregnant and provides no real exceptions for rape or the health of the patient.

AMENDMENT 5

Creates an annual inflation adjustment on the amount that is tax-exempt from a homeowner's primary residence homestead exemption, reducing revenue for local communities by an estimated \$111 million annually by 2029 for services like public safety workers, parks, and sanitation collection.

AMENDMENT 6

Gives more political power to corporations and wealthy individuals and candidates by repealing the public financing option available for state candidate campaigns passed by voters in 1998.
